
Supplementary provisional agenda

#### I. Introduction

- 1. On 30 October 2023 the secretariat received a request from Brazil to include an item in the provisional agenda for the eighteenth session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP).<sup>1</sup>
- 2. In accordance with rule 12 of the draft rules of procedure being applied, and in agreement with the President of CMP 17, this matter has been included in the supplementary agenda as item 14.

### II. Supplementary provisional agenda

- 3. The supplementary provisional agenda for CMP 18, proposed after consultation with the President of CMP 17, is as follows:
  - 1. Opening of the session.
  - 2. Organizational matters:
    - (a) Adoption of the agenda;
    - (b) Election of additional officers;
    - (c) Organization of work, including for the sessions of the subsidiary bodies;
    - (d) Approval of the report on credentials.
