
Supplementary provisional agenda

I. Introduction

- 1. On 30 October 2023 the secretariat received a request from Brazil to include an item in the provisional agenda for the twenty-eighth session of the Conference of the Parties (COP).¹
- 2. In accordance with rule 12 of the draft rules of procedure being applied, and in agreement with the President of COP 27, this matter has been included in the supplementary agenda as item 20.

II. Supplementary provisional agenda

- 3. The supplementary provisional agenda for COP 28, proposed after consultation with the President of COP 27, is as follows:
 - 1. Opening of the session.
 - 2. Organizational matters:
 - (a) Election of the President of the Conference of the Parties at its twenty-eighth session;
 - (b) Adoption of the rules of procedure;
 - (c) Adoption of the agenda;
 - (d) Election of officers other than the President;
 - (e) Admission of organizations as observers;

- (f) Organization of work, including for the sessions of the subsidiary bodies;
- (g) Dates and venues of future sessions;
- (h) Adoption of the report on credentials.
- 3. Reports of the subsidiary bodies:
 - (a) Report of the Subsidiary Body for Scientific and Technological Advice;
 - (b) Report of the Subsidiary Body for Implementation.
- 4. Reporting from and review of Parties included in Annex I to the Convention.
- 5. Reporting from Parties not included in Annex I to the Convention.
- 6. Report of the Adaptation Committee and review of the progress, effectiveness and performance of the Adaptation Committee.
- 7. Warsaw International Mechanism for Loss and Damage associated with Climate Change Impacts.²
- 8. Matters relating to finance:
 - (a) Long-term climate finance;
 - (b) Matters relating to the Standing Committee on Finance;
 - (c) Report of the Green Climate Fund to the Conference of the Parties and guidance to the Green Climate Fund;
 - (d) Report of the Global Environment Facility to the Conference of the Parties and guidance to the Global Environment Facility;
 - (e) Seventh review of the Financial Mechanism;
 - (f) Compilation and synthesis of, and summary report on the in-session workshop on, biennial communications of information related to Article 9, paragraph 5, of the Paris Agreement;
 - (g) Operationalization of the funding arrangements for responding to loss and damage referred to in paragraph 2, including the fund referred to in paragraph 3, of decisions 2/CP.27 and 2/CMA.4.
- 9. Development and transfer of technologies and implementation of the Technology Mechanism: joint annual report of the Technology Executive Committee and the Climate Technology Centre and Network.
- 10. Capacity-building under the Convention.
- 11. Matters relating to the least developed countries.
- 12. Report of the forum on the impact of the implementation of response measures.
- 13. Gender and climate change.
- 14. Consideration of proposals from Parties for amendments to the Convention under Article 15:
 - (a) Proposal from the Russian Federation to amend Article 4, paragraph 2(f), of the Convention;
 - (b) Proposal from Papua New Guinea and Mexico to amend Articles 7 and 18 of the Convention.
- 15. Second review of the adequacy of Article 4, paragraph 2(a-b), of the Convention.

Neither the inclusion of this item in the agenda nor the annotations to it prejudge outcomes on matters related to the governance of the WIM.

- 16. Administrative, financial and institutional matters:
 - (a) Budgetary, financial and institutional matters;
 - (b) Decision-making in the UNFCCC process.
- 17. High-level segment:
 - (a) Statements by Parties;
 - (b) Statements by observer organizations.
- 18. Mountains and climate change: highlighting the need for the protection of vulnerable mountain ecosystems while building the resilience of mountain peoples and economies to reduce loss and damage.
- 19. Operationalization of the principles of equity and common but differentiated responsibilities and respective capabilities, in accordance with Article 2, paragraph 2, of the Paris Agreement.
- 20. Mission 1.5: positive incentives for accelerating early actions and policies that are nationally determined.
- 21. Other matters.
- 22. Conclusion of the session:
 - (a) Adoption of the draft report on the session;
 - (b) Closure of the session.
